INSTRUCTIONS AND NOTES

1. COMPLETION OF FORM

The form is completed by the employer for each month separately. The month of reference is the month from which the tax was deducted.

For tax years up to 2007 please complete the amounts in Cyprus Pounds. The amount will be translated into Euro at the IRD collection offices for the purposes of collection using the irrevocable exchange rate of €1 = £0,585274. As from 2008 complete the amounts in Euro only.

2. PAYMENT OF TAX

Payments can be made in cash, by cheque, by credit card or online via jccsmart. Cheques must be made payable to the "Director of Inland Revenue" and must be crossed. The due tax can be paid online via jccsmart or at any Collection Office of the Inland Revenue Department at the following addresses:
